

**COVID-19 (Novel Coronavirus) Liability Release and Waiver
(For Adult Attendees)**

Due to the emergence of COVID-19 (Novel Coronavirus), the FLORIDA FELLOWSHIP CHURCH MUSIC WORKSHOP has taken the necessary steps to ensure the safety and care of every person that attends our event during this unprecedented time. The World Health Organization (WHO) and Center for Disease Control (CDC) have determined that COVID-19 can be transmitted person-to-person through respiratory droplets and have provided recommendations, guidelines, and best practices with which the FLORIDA CHAPTER OF THE FELLOWSHIP OF UNITED METHODISTS IN MUSIC AND WORSHIP ARTS intends to comply.

(initial) I understand that in order to attend the Florida Fellowship Church Music Workshop,
I must be free from COVID-19 symptoms. Symptoms include:

Fever or chills
Cough
Sore throat
Diarrhea

Shortness of breath or difficulty breathing
Muscle or body aches
Congestion or runny nose

Fatigue
New loss of taste of smell
Nausea or vomiting

While we understand that many of these symptoms can also be related to non-COVID-19 related issues, we must proceed with an abundance of caution during this public health emergency. Adult attendees will need to be symptom free without any medications for 72 hours to attend the 2021 Florida Fellowship Church Music Workshop.

(initial) I will immediately notify a representative of the Florida Fellowship if I become aware of any person, adult or youth, with whom I have had contact exhibits any of the symptoms listed above, is advised to self-isolate, quarantine, or has tested positive, or is presumed positive for COVID-19.

(initial) I understand that the FLORIDA CHAPTER OF THE FELLOWSHIP OF UNITED METHODISTS IN MUSIC AND WORSHIP ARTS cannot be held liable for any exposure to the COVID-19 virus caused by information on this form or the health history provided by each attendee.
